It was **AGREED** that the Council consent to the lease of lands pursuant to the provisions of Section 211 of the Planning and Development Act, 2000 (as amended) and Section 183 of the Local Government Act, 2001. Particulars of the land which the County Council proposes to lease:-

The land: Playing pitches and dressing rooms at Monksland, Athlone, Co. Roscommon.

Owner: Roscommon County Council

The person to whom the land is to be leased to: Monksland Community Development Ltd. Consideration: €5 per annum.

**Term of lease:** Extension of existing lease to total period of 35 years (from 15th October 2007) subject to covenants and conditions.

## 130.16. PRESENTATION BY ROSCOMMON LEADER PARTNERSHIP ON LEADER PROGRAMME 2014-2020

The Cathaoirleach welcomed Martina Early CEO and Tomás Beades, A/CFO from Roscommon Leader Partnership to the meeting. A presentation on the LEADER Programme 2014 – 2020 was made to the members by Thomás Beades. He acknowledged Martin Lydon and Pat Murtagh's role to date co-ordinating the LCDC who are the Local Action Group (LAG) for the LEADER Programme in Co. Roscommon. Roscommon LEADER Partnership is the Implementing Partner while Roscommon County Council is the Financial Partner for the delivery of the LEADER Programme 2014-2020. The total allocation is €8,852,658. This includes Project Funding of €6,581,282 broken down as follows:

Economic Development	€3,600,000
Social Inclusion	€2,381,282
Rural Environment	€600,000

Leader Programme is currently open for calls that require an Expression of Interest (EOI) form to be completed. Following submission, each application will be assessed by an independent committee for recommendation to LCDC. To apply for LEADER funding the applicant or their project must be located in Co. Roscommon. Applications can be made by rural businesses and rural community organisations. New to the programme are:

- Minimum Funding (Grant) Threshold is €5,000
- LEADER can support micro, small and medium enterprises
- Matching funding from other public funded sources (e.g. Fáilte Ireland, local authorities, Waterways Ireland, etc.) is permitted providing it does not derive from an EU fund.
- Targeted Calls for projects

Councillors raised queries and made comments as follows:

- If there is limited interest in rural environment can funding be redirected to economic development if under spent?
- Welcome a more simplified process for drawing down funds.
- Important that LEADER programme is aligned with Local Authority and regular reports are received in relation to progress.
- Are Expressions of Interest Forms submitted over last three years still valid or is there a requirement to resubmit applications?
- Great to see there is matched funding and Municipal Districts will need to consider bigger projects to fund.
- As this is funding of last resort, is there a conflict with Municipal District Funding?
- Welcome the minimum threshold of €5,000.
- What are Creative Industries?
- Will there be a forward timetable for open and targeted calls?
- Since 2013, leader funding was the only available funding and did a lot of good work. Good to see private sector now being included as this will lead to job creation. How much do old projects make up overall budget?
- Will Leader staff be available in the evenings to attend local meetings and what does Rural Youth Funding entail?
- Request that Roscommon Leader Partnership lobby for more funding.
- Information for public is needed to encourage submissions and explain what type of projects is considered eligible.
- What projects are leader encouraging / promoting?
- How can council help rural villages and towns get funding?
- Welcome the RSS & Farm Assist Schemes.
- The last Leader programme had a budget of €12m and the current programme is now €8m this is a 50% decrease.

Martina Earley and Tomás Beades responded as follows:

- There will be a mid programme review to look at the areas of spending and if resources need to be diverted from an under spending area. There will also be at least an annual report for the Local Authorities.
- Leader will try to ensure practicality in application process
- Leader & RCC have created good opportunities working together and so funding should go further as no longer working in a vacuum.
- Renewal energy is important to the Leader programme as now working in a changed landscape. Leader will make changes if required following consultation with the Department.
- Old Expressions of Interest are still valid and all community groups have been emailed however they will have to recomplete the forms.
- The M.D .funds cannot be used as matched funding but Leader maybe able to add value to the M.D. funding.
- Creative Industries area growing sector and part of Innovation Strategy. The funding is not constrained to microenterprises.
- Good idea to have a timetable and the LCDC will consider this.
- There were a large number of old projects but no actual breakdown of cost.
- Leader staff are available during office hours but will not complete E.O.I's on behalf of applicants.
- Information sessions are being held this week.

- Leader will not discourage any projects to be submitted and the funding is available to the entire county.
- There are a total of 500 places available nationally for the Rural Social scheme and Roscommon have applied for the maximum amount of places.
- The Leader programme is about adding value to projects but it cannot fund a project if it is eligible under another scheme.
- Leader welcomes the Rural Social Scheme and will also lobby for the TUS scheme to be increased from one to two years.

Martina Early and Thomas Beades thanked Roscommon County Council for the opportunity to make the presentation to the Members and will work with the members to ensure the delivery of the programme.

## 134.16 REPORT OF THE ATHLONE BOUNDARY REVIEW COMMITTEE

The Cathaoirleach noted that the REPORT OF THE ATHLONE BOUNDARY REVIEW COMMITTEE has just been published and the main recommendation as follows:

The Committee recommends that no change be made to the existing boundary. As a part of the "no boundary change" recommendation, the Committee, added proviso that the process of planned and structured cooperation between the two local authorities for the future planning and delivery of services in the combined Athlone-Monksland/Bellanamullia area be immediately accelerated to deliver sustainable development for Athlone. In the event of substantial non-completion of the four tasks outlined in the report within a four-year period, the committee recommended that the boundary be extended in order to achieve coherent sustainable development for Athlone.

The following issues were raised by the members in response to the report:

• Welcomed the publication of the report but not happy with the four year timeframe.

- If there is not enough cooperation from County Westmeath the boundary extension will go ahead and Roscommon will have not been responsible for the situation.
- If there is a change of Government, what will be the position?
- Very onerous conditions all stacked against Roscommon.
- Roscommon in Catch 22 situation.
- Decision welcomed and validates the work done by Roscommon but with a sting in the tail.
- The fact that so much hanging on the decision there is more clarity required. Roscommon need to set up a working group to ensure that all of the regulations are complied with.
- No reason that what is in the report cannot be used to the benefit of the whole Athlone area if all work together.
- Report includes some positive recommendations.
- Legislation should be enacted that it would require a vote for the people to decide if there is ever to be a change.
- Confident that all requirements and conditions could be met within the four year timeframe.
- There is an opportunity to meet the Minister at the conference on Friday to discuss the report with him.
- The LAP for the Monksland Bealnamulia Area had regard to the National Guidelines what is the purpose of the joint plan?
- Concern of impact of report on Retail Strategy.
- Grant funding is much higher in the West than East (Athlone). Investment has not been put into 'Old Roscommon' by Westmeath.

The Cathaoirleach thanked all of the members for their support over the past year in relation to the Boundary Review. He also thanked the people behind the 28,000 submissions. He informed the members that there would be a Save Roscommon meeting on Thursday night in Monksland community centre.

- Praise for Irish television station TnaG for their coverage of local sports especially GAA.
- Impact on GAA and its 'amateur' status.
