47.16. CONSIDERATION OF CHIEF EXECUTIVE'S REPORT ON THE SUBMISSIONS RECEIVED ON THE PROPOSED MATERIAL ALTERATION OF THE DRAFT CASTLEREA LOCAL AREA PLAN 2016 -2022

Martin Lydon, A/Director of Service advised that the purpose of the agenda item was to discuss the *Chief Executive's Report on the Submissions Received on the Proposed Material Alteration of the Draft Castlerea Local Area Plan 2016 – 2022,* where the report had been previously circulated to Members for consideration on October 7th 2016.

Martin Lydon outlined that we were now at Stage 7 of the plan making process (as outlined in the introductory section of the Report) and that Members were now required to make or amend the Plan, in accordance with Section 20 of the Planning and Development Act 2000 (as amended). He set out his intention to go through the submissions received and detailed in the Chief Executive's Report. He also reminded Members that the Plan had been prepared to be consistent with the Core Strategy as outlined in the *Roscommon County Development Plan 2014* – 2020, which in turn was consistent with the *Regional Planning Guidelines for the West Region*.

<u>Submission No. 1 – Office of the Minister for Jobs, Enterprise and Innovation</u> All Members **AGREED** to accept the Chief Executive's recommendation as presented.

<u>Submission No. 2 – Sligo County Council</u> All Members **AGREED** to accept the Chief Executive's recommendation as presented.

Martin Lydon suggested due to common themes arising in a number of submissions, that it may be beneficial a number of submissions together.

Members AGREED to consider the following submissions together:

Submission No. 3 - Transport Infrastructure Ireland (TII)

Submission No. 4 - Environmental Protection Agency (EPA)

Submission No. 6 - Department of Housing, Planning, Community and Local Government (DHPCLG)

<u>Submission No. 9 – Northern and Western Regional Assembly (NWRA)</u> (part of submission no. 9 pertaining to 'BE' land use zoning i.e. Business, Enterprise Park / Light Industry and Warehousing, with consideration of remainder of submission later in the meeting);

<u>Submission No. 10 – Ellen and Michael Harte</u> (part of submission no. 10 pertaining to 'BE' land use zoning i.e. Business, Enterprise Park / Light Industry and Warehousing, with consideration of remainder of submission later in the meeting).

Martin Lydon summarised the matters raised in the submissions, including reference to certain stipulations made in the submissions from TII and the DHPCLG in the event that lands on the southern side of the railway were to be zoned as 'BE' lands.

Mr. Lydon advised that the recommendation of the Chief Executive in his report remained consistent with the originally prepared Draft LAP and its development strategy, in that the recommendation was that the lands are excluded from the LAP boundary and are not zoned.

Mr. Lydon advised Members, in the event that they chose to include the lands within the LAP boundary and assign a 'BE' land use zoning, that they should also have regard to various caveats in the submissions from TII and the DHPCLG.

On the **PROPOSAL** of Councillor Fitzmaurice

SECONDED by Councillor Dineen

It was **PROPOSED** to zone the lands on the southern side of the railway as 'BE', with an amendment to one area, to be zoned as Transitional Agriculture (TA) in accordance with the request from the landowners in Submission No. 10.

On the PROPOSAL of Councillor Connolly

It was **PROPOSED** to accept the Chief Executive's recommendation. This proposal was not seconded.

On the PROPOSAL of Councillor Fitzmaurice

SECONDED by Councillor Dineen

It was **AGREED** to include the following Specific Objective (SO2) in Chapter 6, page 34 of the Plan, in relation to the 'BE' lands to the south of the railway line:

 - Section 5.2 : Housing Strategy and Residential Development, where reference is made to 'NR' and 'SRR' hectares on Page 29, 2nd paragraph;
 - Page 30 : reference in 'New Residential' description to refer to 'two Greenfield sites' and associated amendments to hectare size;
 - Chapter 7, Section 7.13.1, page 67, Table 4 to include the following amended text in relation to 'New Residential' lands :

'New Residential' lands are identified at two locations in the town, namely:
To the north at Termon between the L6551 local road and the Termon Manor housing development (530m from town centre).

• To the west of the town centre at Arm between the L6554 local road and N60 to its north (800m from town centre).

And

This equates to X.XX Ha of land with a potential for XXX new residential units¹ (see Maps 13 and 13a).

- Chapter 7, Section 7.13.1, page 67, Table 4 to include the following amended text in relation to 'Strategic Residential Reserve' lands :

'Strategic Residential Reserve' lands are identified at three locations in the town, namely:

- Two parcels of land to the south-east of the town accessed towards the end of the L6570 local road (880m from town centre).
- To the west of the town accessed off the L6554 local road (1km from the town centre)

This equates to X.XX Ha of land with a potential for XXX new residential units² (see Maps 13 and 13a).

Submission No. 8 – Department of Education and Skills

Councillor Orla Leyden asked for clarity on whether or not the agreed proposal from Councillor Fitzmaurice in relation to amending all tables and figures to take account of the amendments to land use zonings also applied to Submission No. 8.

Members **AGREED** that was the case and therefore **AGREED** to the Chief Executive's recommendation as presented in relation to Submission No. 8, subject to the figures being modified to reflect the agreed land use zonings.

It was **AGREED** to include an additional footnote in the Land Use Zoning Matrix in Chapter 6 to state the following:

Creche / childcare facilities may be open to consideration on industrially zoned lands, subject to proper planning practices, and where they are ancillary to the industrial use on site and are for use solely to cater for the childcare requirements of employees of the enterprise.

Leyden asked when we could expect a decision on the funding and if drawings could be prepared for the January meeting.

Mr. John Mockler, Roscommon Municipal District Co-ordinator responded to the queries raised:

• An application for funding was submitted under the Low Cost Safety Scheme to enhance road markings and signage in the area. He stated that there would not be enough space for a mini roundabout.

• Enquired if clarification on staffing levels was sought from the Chief Executive

Mr. Derek Caldbeck responded and explained that we did not seek clarification from the Chief Executive as we have come up with another solution for the grass cutting in 2017 thereby making the €60,000 still available to the members.

John Mockler responded and stated that Corporate Services have no plans to change the location of the disabled car parking spaces in the new car park beside Main Street.

It was **AGREED** that the Roscommon Municipal District write again to Roscommon Leisure Centre and request a response before the December meeting

50.16 PROPOSED TAXI RANK AT ROSCOMMON TRAIN STATION:

John Mockler presented the draft maps for a taxi rank at Roscommon Train Station. He explained that he had been in contact with Irish Rail as they have to dedicate a portion of land for the taxi rank. He sought approval from the members to proceed with the dedication of land by Irish Rail.

On the **PROPOSAL** of Councillor Leyden

SECONDED by Councillor Connolly

It was **AGREED** to proceed with the dedication of land by Irish Rail to provide a taxi rank at Roscommon Train Station.

All members expressed their enthusiasm for the proposed taxi rank and John Mockler explained that the public will have an opportunity to make submissions on the proposal.

51.16. PRESENTATION BY LOUGH REE NORTH ANGLING HUB

Lough Ree Angling Hub members outlined:

- Plans to bring fishing competitions to Ballyleague in 2017
- Thanks to Roscommon County Council for their financial contribution of €8,000 towards the 2016 fishing competitions
- Economic spin off from the event
- Details of the food festival
- Interest in developing fishing in all of County Roscommon
- Details of their access for all project which will involve the purchase of a craft specially designed for wheelchair access
- Details of funding requirements for 2017 competitions and request for funding of €7,000 both from Roscommon and Longford County Council

The members welcomed Lough Ree North Angling Hub and complimented them on the success of the project. All members and the management offered their support and emphasised the huge voluntary commitment involved in carrying out a successful project of this nature. They thanked the group for attracting the World Championships to Ballyleague and the fantastic return of €300,000 for County Roscommon from an investment of only €8,000 by Roscommon County Council in 2016.

52.16. SECTION 73 ROADS ACT 1993 (AS AMENDED) – EXTINGUISHMENT OF A PUBLIC RIGHT OF WAY AT LISNACROGHY OR GALLOWSTOWN TOWNLAND, ROSCOMMON

Eugene Dwyer informed the meeting about the right of way being extinguished. He explained that Mr. Kelly had objected and the extinguishment of the public right of way at Lisnacroghy or Gallowstown Townland would not proceed until the new road is in place. The I.D.A. has given a commitment to provide the new road.

On the **PROPOSAL** of Councillor Leyden

SECONDED by Councillor Shanagher

It was **AGREED** to extinguish the public right of way at Lisnacroghy or Gallowstown Townland, Roscommon.

53.16. SPEED LIMIT REVIEW

Mr. Eugene Dwyer updated the members on the current situation with the speed limit review. He explained that the Gardai and Roscommon County Council members will have 31 days to make submissions commencing from the date revised maps are circulated. Following on from this submission will be taken into account and revised maps will be prepared. Approval is required from the TII to agree to proceeding to the stage of public consultation. Maps will then go on public display for one month and following this the speed limit review will go before the Council Meeting for approval. Mr. Dwyer encouraged all the members to carefully examine the maps circulated to them and emphasised the importance of putting forward submissions by writing or by e-mail. He clarified that it would probably be April 2017 before the whole process will be finalised. He highlighted to the members that adopting speed limits is a reserved function and that members will have the final say.

The members raised the following issues:

- Concern regarding the intention of the TII to move in 50km speed limit in places such as Ballyleague and Castlerea especially when the community are looking for traffic calming.
- Request that the recently approved Castlerea Local Area Plan be taken into consideration especially in relation to the speed limits on the N60.

- John Mocker stated that he had no confirmation on funding and date by which money has to be spent.
