59.16 ADOPTION OF MINUTES:

60.16. MATTERS ARISING FROM THE MINUTES:

61.16. DECLARATION OF A PUBLIC ROAD WITHIN CORRAUN VILLAGE HOUSING DEVELOPMENT, CARROWNABRICKNA TOWNLAND, ROSCOMMON

It was **AGREED** that the road located within the Corraun Village housing development at Carrownabrickna Townland, Roscommon be declared a public road.

Cllr. Leyden requested that works now proceed with completing the minor remedial works to the underground.

John Mockler stated that it would be unusual for works to be outstanding on a road that was to be taken in charge however he agreed to investigate if works were required and to revert with more information.
