#### 111.15. DRAFT BUDGET 2016

The Cathaoirleach welcomed the members to the Budget Meeting and informed them that the Budget was broken up into eight Divisions plus the 3 year Capital Programme. Each Director of Services would outline the Budget to the members for their respective areas of responsibility. He thanked the members of the Corporate Policy Group for their hard work and assistance in the preparation of the draft Budget. He also welcomed the Transition Year students from the C.B.S. to the meeting

It was agreed that the Resolution for adoption of the Budget would be taken at 4.00 p.m.

Mr. Eugene Cummins, Chief Executive, addressed the members and stated that the draft budget for 2016 has been prepared in accordance with the provision of Section 102 of the Local Government Act 2001 and reflects the input from the members of the Corporate Policy Group.

He continued that the new focus and priority for Roscommon County Council is that of economic and community development. This will require a restructuring of the organisation with a more expanded and meaningful role for the Municipal Districts while the Plenary Council concentrate on strategic issues to grow and drive the County forward.

He commended the members for not reducing the Local Property Tax. He stated that the draft budget as presented allows for the provision for the focus and the various funding streams to facilitate for the preparation of plans and policies to drive the county forward.

He continued that local authorities are required by law to adopt a budget that is sufficient to meet their proposed expenditure – total estimated expenditure must be met with total estimated income from commercial rates, local property tax, charges for goods and services, and government grants. In addition to adopting the budget for the coming year, Elected Members must also determine the annual rate on the valuation that should be levied on commercial properties. The Draft Budget is based on no increase to the current Annual Rate on Valuation.

The Chief Executive thanked the Cathaoirleach, Elected Members and staff of the Council for their assistance in the preparation of the draft budget.

Finally, he thanked, especially, Mr. Martin Lydon, Head of Finance and Planning and the staff of the Finance section, the Directors and all staff who contributed to the preparation of the draft budget.

#### The Chief Executive recommended the Budget for adoption.

Directors of Service, Ms. Majella Hunt, Mr. Martin Lydon, Mr. John O'Rourke and Mr. Pat Murtagh introduced the services under Division A,B,C,D,E,F,G & H namely Housing and Building; Roads Transportation and Safety; Water Services; Development Management; Environmental Services; Recreation and Amenity; Agriculture, Education, Health & Welfare and Miscellaneous Services .

- Request a more detailed presentation on the Tenant Purchase Scheme at the next Municipal District meeting
- Welcome the allocation for swimming pools great need for recreational facilities in the county
- Number of bridges in needs of repair
- Need for low cost safety measures by means of flashing lights
- Welcome €35,000 allocation for burial grounds
- Query if Fairymount Graveyard is included
- Query what reservoirs are to be demolished
- Welcome the continuation of the Green Schools
- Welcome the introduction of the Rates Incentive Scheme
- Concern that banking sector will not be on board with the new Tenant Purchase Scheme and financing will be left to the local authorities.
- Need for greater flexibility if local authority are to become lenders
- Compliment the Housing Section for work on affordable sites at Forest View, Boyle
- Query the possibility of residents purchasing the remaining 9 sites in Forest View on a conditional basis
- Welcome the increase in allocation to amenity grants
- Excellent work being done through Local Enterprise Office
- Welcome the allocation of €1.2m to the Library Services
- Improvement works required to many roads in the county onus on TII to address many of these issues
- Query the level of funding and support provided by Roscommon County Council for community tourism offices
- Update sought on Kilbegley Cemetery
- Funding ring-fenced for maintenance in Monksland
- Roscommon County Council should call in bonds in relation to unfinished housing estates
- Household Charge taken by Central Government has made no impact to the budget of Roscommon County Council

- Inadequate amount of funding allocated for land drainage
- Welcome hot-desking facility
- Huge improvement on waste management will funding include pay-by-weight?
- Is funding included in the budget for the 2016 Programme?
- Additional staff resources required in Housing Section to deal with homelessness, voluntary bodies, RAS, etc.

It was **AGREED** that Roscommon County Council would investigate the possibility of using funds allocated through Environmental Protection to maintain and improve the appearance of bring banks.

It was **AGREED** that Roscommon County Council request the TII to address the provision of a right turning lane at Ballymurray in the interest of safety.

#### It was **PROPOSED** by Councillor Connaughton

#### SECONDED by Councillor Leyden

That the cost of supporting Roscommon Racecourse be split equally between each Municipal District.

#### On the PROPOSAL of Councillor Murphy

#### SECONDED by Councillor Cummins

It was **AGREED** that Roscommon County Council request the Government to introduce new legislation whereby developers who were in NAMA but are now again making profit be obliged to complete their unfinished estates.

#### On the **PROPOSAL** of Councillor Cummins

#### SECONDED by Councillor Byrne

It was **AGREED** that the €8,300 be taken from each Municipal District Budget (non-TiC Public Lighting) and given to Amenity Grants to bring to a total of €59,900 for 2016.

The Directors of Services responded to all queries raised as follows:-

- Information of the new Tenant Purchase Scheme will be circulated to all members and a member from Housing will be happy to give a presentation on the new scheme at the next Council meeting, if so required.
- The figure for income from housing rents remains the same as 2015 as some rents has decreased as a result of the rent review while others have increased.
- Differential Rents Scheme is a national scheme based on the Housing Act Roscommon County Council does not have any remit to make changes.
- No provision for emergency accommodation in every town in Co. Roscommon
- No definite timeframe for the rollout of HAP have to assume 2016
- Welcome comments on swimming pools
- Flashing lights are currently used at accident black spots
- Municipal District Engineers aware of the problem areas however funding is the issue
- Funding from the TII is based on accident figures
- Roscommon County Council has been in communication with the TII in relation to turning lanes on the N61 with no positive response.
- Archaeological study of Kilbegley Cemetery not yet complete
- Aim to deal with a percentage of overgrown trees in cemeteries on an annual basis within existing resources
- Gardaí are aware of the issue of speed in Ballinlough village
- Upgrade required to Elphin Library Government have announced a capital library scheme
- Will investigate options for acquiring funding for Edenville House
- 8 reservoirs have been indentified for demolition over the next 3 years these are Strokestown, Gallowstown, Keadue, Tullyloyd, 2 in Boyle, Roosky and Castlerea
- Further household waste management regulations will be introduced in July 2016 Local Authority will have a watching brief may be necessary for SPC to adopt bye-laws
- Issues being addressed in Lough Gowna
- Procurement of 5 fire engines for the counties of Leitrim, Galway, Sligo, Donegal & Roscommon location of new appliance in Co. Roscommon is not yet determined as an assessment needs to be carried out on existing vehicles.
- An allocation for the 2016 Celebrations of €100,000 is included under the heading of Tourism Development and Promotion in the Budget

- It is a decision of the Municipal District to allocate an amount of funds to support the Roscommon Racecourse there is an allocation of €85,000 for the Municipal District members to decide how it is spent.
- Public lighting money is for the payment of lighting as well as the maintenance of lights
- The funding of land drainage works is part of the Municipal District Budget
- As determined by the Planning & Development Act, a housing estate is a development of 2 or more houses. There are 211 unfinished estates in the Co. of Roscommon.
- If additional funding becomes available for community awards funding this will be communicated through the CPG
- The homeless budget is demand-led with 90% of expenditure recoupable
- On 17<sup>th</sup> April last, Roscommon County Council received notification of their housing budget for the period 2015 – 2017 which amounted to €5.6million. This allowed for the provision of 152 housing units which consists of 25 acquisitions, 18 new builds and 109 long-term leasing through the RAS Scheme.
- Housing budget is demand-led
- Voids programme in place for the upgrade of 120 houses
- There are different housing schemes throughout the year available aside from the Budget as presented.
- Under Waste Management Regulations, Contractors are obliged to create a database of users and make this available to the local authority
- No capital funding yet provided for the upgrade of the Elphin Fire Station a number of repairs and general maintenance works has been carried out over the last number of years

# As all members had spoken on the Budget the Cathaoirleach called for Motions on the adoption of the Budget.
