# 34.17 CONSIDERATION OF CHIEF EXECUTIVE'S REPORT ON THE SUBMISSIONS RECEIVED ON THE DRAFT VARIATION NO. 1 OF CASTLEREA LOCAL AREA PLAN 2016 – 2022

Martin Lydon, A/Director of Services outlined the background that required the variation to give expression to changes required as part of the Urban Regeneration and Housing Act, 2015.

Section 10(2)(h) of the Planning and Development Act 2000, as amended, by the Urban Regeneration and Housing Act 2015, requires that the development plan and, by extension, LAPs should include a development objective for:

"the development and renewal of areas, identified having regard to the core strategy, that are in need of regeneration, in order to prevent-

- (i) Adverse effects on existing amenities in such areas, in particular as a result of the ruinous or neglected condition of any land,
- (ii) Urban blight and decay,
- (iii) Anti-social behaviour, or
- (iv) A shortage of habitable houses or of land suitable for residential use or a mixture of residential and other uses"
