Safety Issues on the N61

“Can the Director of Services please inform the meeting if the consultants that were appointed by TII have examined the safety issues relating to the N61 from Ganly’s roundabout to the turn off for the L7554-0 for the St. Brigid’s GAA Centre and into the villages of Carrowmurragh-Purts and Moyvannion? Has there been any further update in relation to this issue?”

“Can the Director of Services please inform the meeting what is the hold up in carrying out the necessary works at Cloonakilla NS.?
