A request was received to have the roads located within housing development at the following location in the Boyle Municipal District declared to be public roads:

- The Fairgreen, Frenchpark
- Foxwood Manor, Boyle
- Bramble Hill, Boyle
- Silveroe, Boyle

In accordance with Section 11 (2) (b) Roscommon County Council has:

- Satisfied itself that the roads is of general public utility.
- Considered the financial implications for the authority of the proposed declaration.
- Published the required notice in the Roscommon Herald, dated 20 May 2025

The final date for submissions in relation to the declaration was 5pm on 1 July 2025. No objection or representation was received.

The declaration of a roads to be a public road is a reserved function to be performed by Municipal District Members. The Council will be charged with the future maintenance of the roads. Drawings are attached showing the roads to be taken in charge.

It is accordingly recommended that the roads referred to be declared public roads.

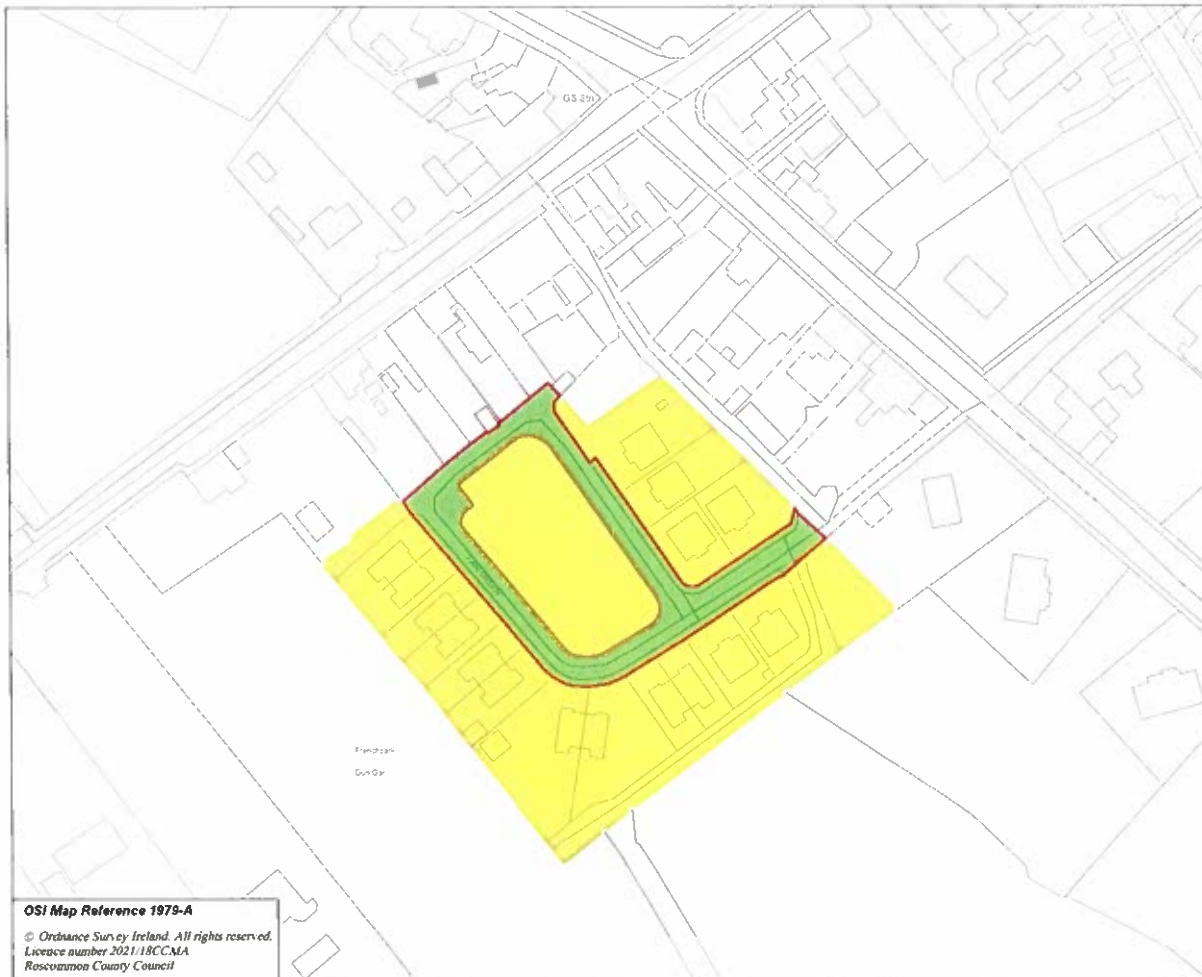

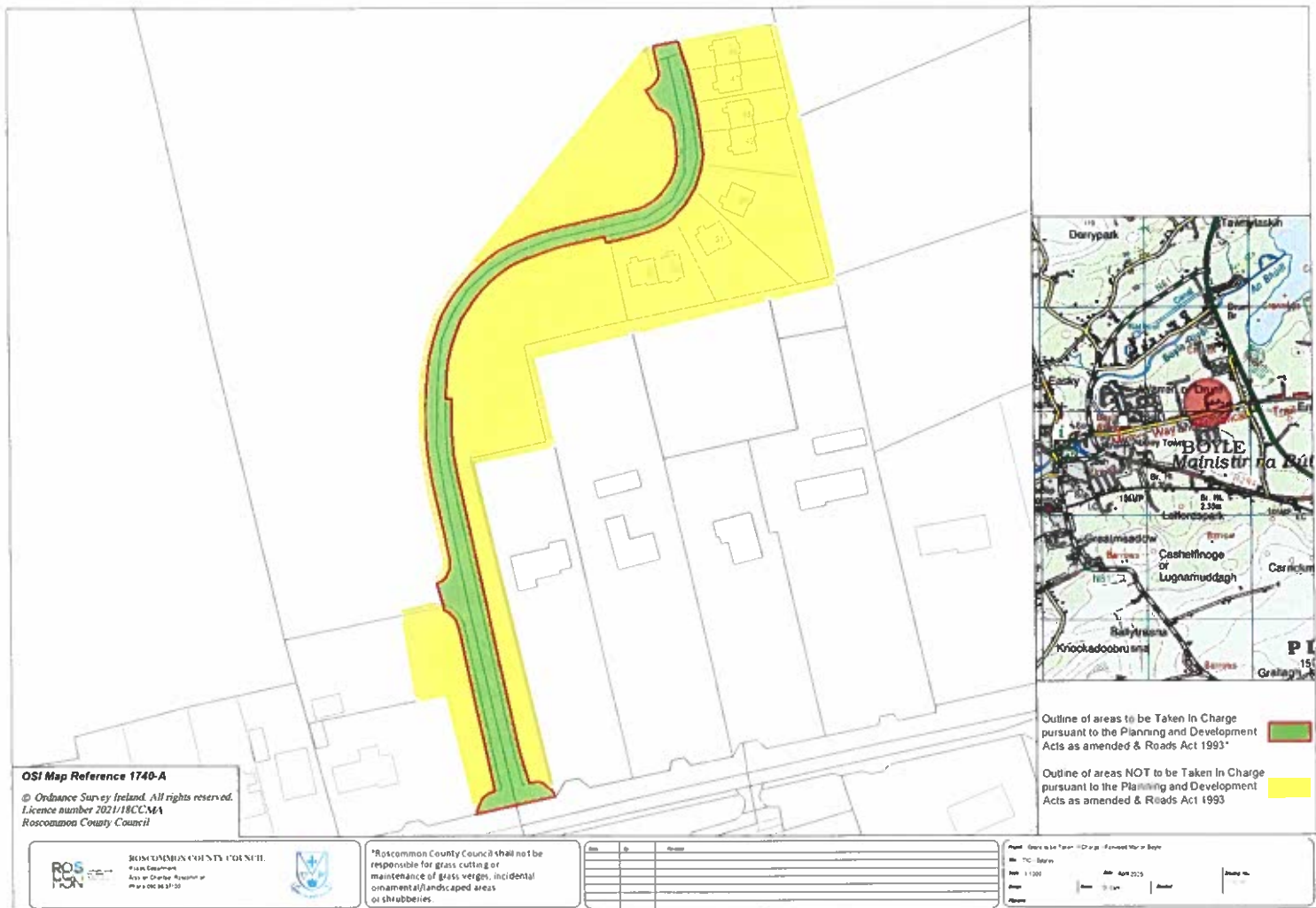
