# 51.15. ADOPTION OF MINUTES:

It was **AGREED** to adopt the Minutes of the Athlone Municipal District held on 19.10.2015 and Budget Meeting for Athlone Municipal District held on 09.11.2015.

#### Matters Arising:

Ms. Majella Hunt, Director of Services responded to issues raised as follows:

- Galway County Council is the lead authority on the M6 project. Roscommon County Council will seek a meeting with the Project Office on the new year.
- Members may need to meet themselves in advance of the meeting with the project Office to agree issues to be raised.
- The archaeological survey of Kilbegley Cemetery is not yet complete it is expected in early 2016.
- €8 million was announced yesterday for river funding. Each local authority is responsible for submitting their own request. At present Roscommon County Council only funds arterial drainage works
- Roscommon County Council undertook to monitor speed on the Old Tuam Road in liaison with the Gardaí no commitment was given to install signs.
- Improved signage and monitoring of speed will need to be investigated at Mount Talbot National School.
- A traffic count is currently being conducted at Castlecoote National School
- Works on the L2018 will be included in 2016 works programme no traffic count has been conducted

• There was no timeframe outlined for the completion of the survey on Kilbegley Cemetery

Mr. Diarmaid MacDonncha, Senior Executive Engineer responded to the issues raised as follows:

- Roscommon County Council commissioned a report from Consultants and have identified the problems on the M6.
- Speed survey is complete on the Old Tuam Road Roscommon County Council to discuss issue with Gardaí

# **52.15. ATHLONE BOUNDARY REVIEW**

Ms. Majella Hunt, Director of Services informed that meeting that a Boundary Review Committee has been set up by the Minister. There is a public consultation process in place and submissions are due before 27<sup>th</sup> January 2016. She stated that the members workshop held recently was very productive and that any changes to the boundary of Co. Roscommon will have a huge impact on both the Municipal District and the County as a whole. She confirmed that a special meeting of Roscommon County Council will be held on 6<sup>th</sup> January next to discuss the issue.

The members raised the following issues:

- Thanked Majella and staff of Roscommon County Council for their work on the boundary review
- Members workshop was very beneficial and very welcoming
- Welcoming to see Councillors present from other Municipal Districts of Co. Roscommon
- Need to organise to march on the bridge of Athlone and hand deliver a letter to Westmeath Offices
- Thanked Councillors for their input into the Committee
- State bodies such as Eircom and Department of Social Welfare have from to the East of the River Shannon
- Absence of female representative on committee is disappointing
- Concern on developing Athlone as a super town
- No representative from Roscommon County Council in attendance at Westmeath County Council meeting

- Need to fight for 100% retention and not 80%
- How do Roscommon County Council propose to improve the functionality of Athlone need to formalise service level agreements, etc. between Westmeath Co. Co. and Roscommon Co. Co.
- Need to explore consideration of extending the boundary back to the natural boundary of the River Shannon
- Monksland has been identified as having bio-pharma potential for development in Action Plan for Jobs document
- All Westmeath Councillors are in favour of the proposed changes to the boundary
- Why were Westmeath County Council chosen as lead authority on the matter?
- Cannot let 'land grab' happen
- Monksland is a highly populated area with 'clean' industry
- Appeal to media to inform the public of public meeting scheduled for January 11<sup>th</sup> in the Athlone Springs Hotel

- Inclusion of the schools in the delivery of the flag and the proclamation excellent initiative
- Level of funding is available to groups?

Mr. Richie Farrell, County Librarian responded to the issues raised as follows:

- Programme is still a work in progress groups must apply in the next 2 weeks to be included in the programme.
- Thanked his colleagues for all their hard work behind the scenes
- Committed to contact Drum Heritage Centre
- €150,000 approximately to run the programme of events

# MUNICIPAL DISTRICT ALLOCATIONS

Notice of Motion from Councillor Naughten – 13/15.

"That Roscommon County Council report on request made to have funding allocated to take account of population in each Municipal District, as roads funding is presently allocated on a per kilometre basis."

The Meetings Administrator read out the following reply:-

The following models were presented to the Corporate Policy Group on 25<sup>th</sup> May:

- 1. Area Budgets based on length in new Municipal areas (the current situation)
- 2. Area Budgets based on population.
- 3. Area Budgets based on 50% lengths and 50% population.

The population model would lead to a significant increase in funds to the Athlone Municipal District at the expense of the Boyle Municipal District.

At the request of the Corporate Policy Group (CPG), work was carried out to ascertain how other local authorities distribute funding. This work concluded that there are a number of models in place throughout the country. This information will be presented at the next CPG.

Councillor John Naughten thanked the Meetings Administrator for the response. However, he stressed that the issue needs to be addressed as a matter of urgency before the Budget meeting as Athlone Municipal District receive inadequate levels of funding at present.

The members raised the following issues:

- South Roscommon receive the lowest allocation of the three Municipal Districts
- Allocation per population may be a fairer method for distribution of funds.

- Municipal Allocations should be equal
- Athlone Municipal District is an extensive area with large population
- Athlone has the lowest electorate at 29.5%
- Leitrim County Council make provision to amend allocations in specific areas

# Custume Barracks

Councillor Tony Ward queried if there has been any update on the proposed meeting in relation to Custume Barracks, Athlone.

Ms. Fíona ní Chuinn, Meeting Administrator confirmed that she had been in contact with the Meetings Administrator for Westmeath County Council and no date has been arranged yet.

# CIE/Iarnród Éireann

Councillor John Naughten raised the issue of inadequate parking available at the Athlone train station resulting in many incidents of clamping.

It was **AGREED** that Roscommon County Council write to CIE voicing their concern with the implementation of strict clamping.

# Development of Land in Monksland

Councillor Paddy Kilduff highlighted a concern that submissions are being made from individuals in Belfast and other areas outside of County Roscommon on planning applications in the Monksland area.

Councillor Tony Ward stated that the County Development Plan and Local Area Plan should reflect the views of the community and hoped development will continue in the Monksland area.

Mr. Des O'Dwyer, A/Director of Services confirmed that any person can make a submission regardless of where they are from.

# **Underground Bring Bank in Monksland**

Councillor John Keogh informed the meeting that a community group have land available for the installation of an underground bring bank facility near Super Valu and Athlone Springs Hotel. He understands that Westmeath County Council have installed 6 underground bring banks in the Fairgreen area in Athlone. It reduces the problem of broken glass and vermin. The cost is €6,000 per bring bank.

The following issues were raised:

- A representative from the bring bank company should come to make a presentation to Roscommon County Council.
- Investigate underground bring banks for all towns throughout the county.
- Request Municipal District Engineer to examine the matter
- Inadequate monitoring of bring bank facilities

It was **PROPOSED** by Councillor Keogh **SECONDED** by Councillor Ward

That Roscommon County Council make a piece of land available in Monksland to progress this project.
