- Establishment of a new unit in Planning Section in 2016 to look at town dereliction and will be a positive development to grown and enhance town centres

- Welcome funding for works at Oran
- Condition of and lack of funding for works on N63, N60, R357 and L2013
- Public lighting at Monksland and exits off the Ballaghaderreen bypass
- N5 not included in the Winter Services Programme
- Dangerous junction at Frenchpark, issues at Boggafin to Rooskey Cross
- Lack of turning lanes on N61 requires funding. Request capital funding for new route and include bypass of Roscommon Town.

Mr. Martin Curley, Senior Engineer responded to the queries raised as follows:

- The expected duration for the Rathallen project is 9 months
- Oran project has completed planning stage and awaiting approval to proceed.
- The provision of public lighting on the Ballaghaderreen bypass is the responsibility of the TII it is no longer normal practise to light junctions
- Limited funds available for the N60 however Roscommon County Council will continue to raise the issues
- Significant traffic volumes on N61 will investigate short term measures

- No funding for new public lights
- Impact of Winter Services programme on Municipal District budgets
- Design is complete for revised junction at Frenchpark
- Assess additional turning lane on N61

- Rollout of e-fibre is there proposals to replace the copper wires in rural countryside
- Jobs will be lost on the issue of lack of broadband
- Many businesses struggling with broadband connection
- Roscommon County Council should make provision for future cabling while upgrading the road networks in towns and villages
- Will towns and villages be prioritised ahead of rural areas
- Slow pace of rollout will damage foreign direct investment

Ms. Deirdre Frost responded to the issues raised as follows:

- Funding and National Broadband Plan in place to make the project cost effective
- Reduction of cost of MANs
- Sufficient levels of Government funding required
- Progress benchmarked by activity in large urban centres

Chief Executive Mr. Eugene Cummins stated that the loss of Monksland would decimate the Municipal District of Athlone and it will not be possible to nominate South Roscommon as a Municipal District in Co. Westmeath as it would be devoid of urban centre. He will advise members in due course in terms of the legal concerns.

Ms. Fíona ní Chuinn, Meetings Administrator read a letter received from the Office of the Taoiseach acknowledging receipt of correspondence from the members of Roscommon County Council and confirming that the correspondence has been forwarded to Minister Alan Kelly for his attention and direct response.

11.16. POBAL DISTRIBUTION OF GOVERNMENT GRANT TO COMMUNITY SERVICES PROGRAMME

Councillor Byrne stated the increase in the minimum wage is not being reflected though the Pobal distribution of Government grants to the Community Services Programme (CSP). Employers are expected to make up the shortfall of 0.50cent per hour for employees that are employed through the CSP Scheme.

The Meetings Administrator read the following reply:-

The six Community Tourism Centres were established by Roscommon LEADER Partnership as part of an initiative to strengthen the role of local communities in tourism. They were not established to replace the Fáilte Ireland tourism offices originally in Roscommon and Boyle towns but to give a stronger role to communities in their local tourism offerings. The centres are members of the Community Tourism Network and get ongoing support from LEADER, TUS and Pobal. It is anticipated that the Community Tourism Centres will continue to play a role in community tourism in County Roscommon but no direct financial support has been provided by Roscommon County Council towards their operation.

Councillor Naughten stated that there is very little financial support for Tourist Offices. He said some funding needs to be put in place to maintain the Tourist Offices as part of the new economic and community role of the local authority.

Mr. Eugene Cummins, Chief Executive confirmed that support for Tourist Offices will be considered.
