09.16 Notice of Motion from Councillor Naughten - 09/16

"That Roscommon County Council ensures adequate funding is provided to carry out verge trimming particularly at junctions throughout County Roscommon".

The Meetings Administrator read the following reply:-

Roscommon County Council are currently spending approximately €15,000 per week on verge trimming. Given the road maintenance requirements for the remainder of the year on pothole repair, winter gritting, etc, this is considered a prudent level of expenditure. It is intended to concentrate on junctions on National and Regional Roads for the next month.

The members raised the following issues:

- This is the single biggest issue that public have reported to members
- €780,000 is a huge amount money being spent annually Are we spending €15k per week or is this just for summer months?
- A lot of growth at moment and junctions are very dangerous
- Overgrowth on roadsides dangerous for cyclists
- Possibility of getting an extra cutter out would be helpful

Chief Executive Eugene Cummins informed members that verge trimming is not permitted during summer months only at junctions with sight issues and only to give sight distance.

ÁRAS AN CHONTAE OFFICIAL OPEN DAY

Councillor Shanagher thanked all staff of Roscommon County Council for organising the hugely successful open day in conjunction with the official opening on 17th June.

ROSCOMMON TIDY TOWNS

Councillor Shanagher informed members that Roscommon were unsuccessful at the recent "Ireland's Best Kept Towns" Ceremony in Belfast but thanked the staff for all assistance given to Roscommon Tidy Towns Committee during the year but noted that they lost points on grass cutting.

SHANNON BLUEWAY

Councillor Naughten had previously requested a presentation from Waterways Ireland. Martin Lydon, Director of Services will speak to the Upper Shannon Erne Future Economy Co-Ordinator, Sheena O'Dowd and the Cathaoirleach to organise a presentation on the Shannon Blueway.

FLOODING AT CURRAGHROE

Cllr Connolly asked if the Council is satisfied that all planning regulations were followed by Coillte in relation to the development that's ongoing on Sliabh Bán and queried if any study had been carried out in relation to the events of the 15th June where a number of houses were flooded in Curraghroe and surrounding areas.

Members also raised the following concerns:

- Is there a correlation between events of 15th June and the development of Sliabh Ban Windfarm?
- Did the tree clearance contribute to the flooding?
- Funding allocated to upgrading of drainage needs to be increased

Martin Lydon, Director of Services responded as follows:

On Wednesday 15th June 2016 unprecedented volumes of rainfall were experienced in the vicinity of Sliabh Bán mountain. On 22nd June a Council engineer visited Sliabh Bán and found that there was no evidence of damage or soil erosion on the site. A stream had been cleaned by Coillte and it was found that there was overgrown shrubbery on adjoining lands. Overall it is a well managed and monitored site, constructed to a good standard. Between the hours of 5pm and 8pm, 89.2mm of rain fell in the area. This is 83% of the highest recorded monthly rainfall and 50% of highest monthly rainfall in 1 hour. This is a 1 in 250 year event (Met Eireann). This is historical rainfall and could not be foreseen. It is totally unnecessary to suspend any works. I have asked Coillte for a copy of their response to events on that day. We are in regular contact with Coillte and have nothing further to add at this time.

Chief Executive, Eugene Cummins responded as follows:

I want to make it 100% clear that Roscommon County Council Planning Department has no issue with the ongoing development on Sliabh Bán. Flooding was the result of high intensity rainfall that happened in a very short time that was outside of people's control. We will not be seeking an independent assessment of flooding to be carried out. There is no evidence that removal of trees caused flooding or added to events of that day. Expenditure on drainage in general needs to be improved, roadside drainage, land drainage etc. The diversion of funds is allowable if you want to increase expenditure on drainage. We will be seeking additional funds to deal with issues on flooding in the County e.g. Loughfunshinagh

BREXIT – Reinstate 4th Western Brigade

Cllr Connaughton is calling on the government to reinstate the 4th Western Brigade at Custume Barracks, Athlone. If border needs to be patrolled, then Athlone is geographically best positioned to do so.

On the **PROPOSAL** of Councillor Connaughton

SECONDED by Councillor Keogh

It was **AGREED** that a letter be sent to Mr. Enda Kenny, Taoiseach and Minister of Defence requesting the reinstatement of the 4th Western Brigade at Custume Barracks, Athlone.

BROADBAND

Councillor Dineen welcomed high speed broadband to Ballintubber which will be connected on Wednesday next and anyone within a 1km radius of Ballintubber will get connected.

LIBRARY SERVICES

Councillor Kilduff is concerned that Roscommon Library will become a shared service and requested the post of County Librarian to be filled immediately.
